Additional Insureds & Marine Insurance

•Coverage for additional insureds under marine insurance policies operates in much the same way as coverage for additional insureds under non-marine policies •However, marine insurance policies are subject to federal maritime case law rather than any particular state's law, unless there is no entrenched federal case law on point
